## Del. Firm Landis Rath Adds Pachulski Stang **Bankruptcy Ace**

Law360 (June 12, 2025, 2:47 PM EDT) -- Delaware boutique firm Landis Rath & Cobb LLP has brought on a former Pachulski Stang Ziehl & Jones LLP attorney to enhance its ability to advise clients on Chapter 11 and other bankruptcy proceedings and related litigation.

Colin R. Robinson joins Landis Rath as a partner in its corporate bankruptcy and restructuring, bankruptcy litigation and corporate litigation practices, the Wilmington-based firm announced earlier this week.

Robinson told Law360 Pulse on Monday that he made the move to Landis Rath because of its small boutique culture and the chance to work with his new colleagues, many of whom he has known for years.

"It was just a great opportunity," he said of joining the firm, and a great "culture fit" for him. He said he started at Landis Rath late last month and that the transition has been "seamless."

"I had a fantastic 12 years [at Pachulski Stang]," Robinson said. "It was a great place to learn and grow as an attorney. This is just the next natural step for me."

Among his more recent work at his former firm, Robinson was on counsel teams representing the official committee of unsecured creditors in hospital chain CarePoint's **Chapter 11** in Delaware. Robinson was also one of the attorneys for the foreign representative of Toronto-based geothermal energy company STS Renewables Ltd. in its Delaware Chapter 15, and served on a team representing the official committee of unsecured creditors in pharmaceutical company Azzur Group's **Delaware Chapter 11.** 

In addition to this time at Pachulski Stang, Robinson's prior experience includes three years at Delaware firm Bayard PA, six years at Saiber LLC and more than a year at Blank Rome LLP, his LinkedIn profile says.

He earned a law degree from Temple University's Beasley School of Law and a bachelor's degree in history from the University of Pennsylvania.

In his practice, Robinson represents various stakeholders in Chapter 7, 11 and 15 bankruptcy proceedings, related litigation and appeals, Landis Rath said.

Robinson said he plans to grow his overall practice at Landis Rath, including handling more assignment for the benefit of creditors matters in Delaware's Court of Chancery. The state-governed liquidation process can be a cheaper and quicker alternative to filing in bankruptcy court, Robinson said.

In addition to his practice, Robinson serves as an officer of the Turnaround Management Association's Philadelphia/Wilmington Chapter and co-chair of the TMA Mid-Atlantic Regional Symposium. TMA is an organization of professionals focused on "empowering organizations for a stronger future," its website says.

"We're thrilled to have Colin as a partner, as he brings extensive experience in complex restructurings in bankruptcy court and the Court of Chancery, which is one of our core practices areas, and one where we've seen significant growth over the last several years," firm founding partner Adam G. Landis told Law360 in an emailed statement on Monday. "Because we've all known and practiced with Colin for many years, and because he's so well regarded in the industry, we couldn't be more excited to have him join our tight-knit group."

Landis added that Robinson will "help service existing clients and enable us to continue to expand our practice, which covers all the major players in restructuring, including debtors, official creditors' committees, asset purchasers, major creditors, boards and special committees, assignees and assignors for the benefit of creditors, and wind-down entities."

Since the firm opened in 2003, it has aimed to do "sophisticated 'big law' work in a boutique environment, less constrained than we were when we practiced in larger firms," Landis said.

"This year in particular has been incredibly rewarding, as we've added three more associates to help service our growing bankruptcy and corporate litigation practices," he added. "Colin's arrival will help us grow and expand without sacrificing the small-firm feel and quality of life that makes LRC such a special place to work."
